#### INSTRUCTION PROCEDURES

### **FOR**

#### SWIMMING POOL INSTALLERS

- 1. All pool installers must be licensed by the Natick Board of Health prior to any pool installations. (Annual Fee \$325.00)
- 2. If you are applying for a customer's pool construction permit, the following must be included:
  - a) Obtain applications at the Board of Health Office and return completed in full.
  - b) Property owner's signature must appear on the bottom of both copies of the application.
  - c) Re-circulation time must be calculated for the particular pool that is being installed.
  - d) Plot plan drawn to scale showing the following:
    - 1. Location of all structures in regards to the pool.
    - 2. Distances of lot lines in regards to the pool.
    - 3. Location of filter and backwash pit.
    - 4. If not on town sewer, location of septic system.
    - 5. Location and type of fencing enclosing the pool.
  - e) Submit literature on the specific filter that is to be installed
- □ Note: All filters must be connected into a backwash pit, unless indicated by the Board of Health.
- 3. When plans have been reviewed and a satisfactory inspection of the property has been made, then permits will be granted and construction allowed beginning. Fees for said permits are due at this time.

Fee Schedule: Pools 15,000 gallons and under.....\$75.00

Pools over 15,000 gallons.....\$200.00

- 4. It is imperative that the Board of Health be notified when construction is to begin and especially when construction of the pool has been completed.
- 5. THE POOL SHALL NOT BE FILLED WITH WATER UNTIL SATISFACTORY INSPECTIONS ARE PERFORMED BY THE ELECTRICAL INSPECTOR, BUILDING DEPARTMENT AND THE BOARD OF HEALTH.
